Background

Global climate change and continued poverty are probably the two largest, long-term challenges for human development. Both issues have been addressed in recent international agreements, respectively in the UNFCCC Paris Climate Agreement and agreement on UN Sustainable Development Goals (SDGs), both agreed in 2015. Now, the key issue is how to reduce these global problems during the implementation phase of these agreements, where regional and national strategies and actions, as well as financing are crucial. As a densely populated and fast growing region, but still with a large part of the population living in poverty, development of South Asia is strongly linked with these two global issues. It is expected that South Asia's emerging economies will bring an increase in living standards for many people in the region. However, with emerging economies and expanding populace, greenhouse gas emissions will increase along with the advanced consumerism of the emerging, primarily urban, middle class, and technological development of industries, while the development tends to leave large parts of the rural population in poverty. The two challenges of poverty and climate change can be addressed with one set of solutions, as we in the EVD project are doing with the locally-based eco-village development concept and solutions.

After the successful implementation of *Evidence Based Advocacy for Low-Carbon Pro-Poor Sustainable Eco Village Development in South Asia* (EVD) project (2015-2017), with support from same partners Civil Society in Development (CISU), coordinated by Danish International Human Settlement Services (DIB) and International Network for Sustainable Energy (INFORSE), Centre for Rural Technology, Nepal (CRT/N) has initiated project "***Advocating for up scaling for local climate solutions as Eco Village Development as a mean to strengthen pro-poor climate agenda in South Asia***" from September 2017.

The EVD concept combines a number of solutions for poverty reduction within sustainable energy, water management, agriculture and housing. The solutions have all proven successful individually, and in several cases also together, as promoted in the EVD project. Combined, they can provide the energy and resources needed for a development out of poverty for rural villages with minimal greenhouse emissions, giving a prosperous vision for the future of rural villages. Individually, the solutions can provide for instance cleaner cooking, light or better gardening. Together they can fulfill basic needs and provide energy and resources for increased income generation.

The overall objective of the project is to strengthen development for reducing poverty in ways that limit greenhouse gas emissions (mitigate climate change) and adapt to climate change in South Asia by better including local climate mitigation and adaptation solutions in the implementation of the Paris Agreement and relevant SDGs, and as well as in proposals from South Asia for international negotiations such as within the UNFCCC. For this purpose, it was realized that, local government and other active members of the communities who can be considered as an agent of change, need to be sensitized about these issues and make them familiar about the problems and solutions that they can implement from their local level to tackle these problems. These groups are mainly focused to orient on above topic, as they are influential one and communities listen to them.

In this context, CRT/N organized “**Orientation Program on EVD, Climate Change, and Environment to the Agent of Change**” from 21-26 May 2018 to the 6 wards of Bethanchok Rural Municipality in collaboration with them.

Objectives

- To sensitize and orient the community members specially representatives from local government and active members about the Eco-Village Development Concept and its components
- To provide Orientation to the participants regarding climate change science, climate mitigation/adaptation and through them to the community members
- To identify potential EVD solutions that can be included in the coming fiscal planning document of rural municipality

Activities

The major activities carried out were as follow:

i. **Presentations on Importance of Environment Conservation, Climate Change, EVD concept and Renewable Energy Technologies**

EVD team members Shovana Maharjan and Subas Lamichhane sensitized participants about the importance of environment conservation, climate change, mitigation, adaptation, and EVD concept through the detail presentation. Presentation topic and schedule is present in the Annex I.

ii. **Video Documentaries about climate change and EVD activities**

Video documentary are effective visual measure to present participants about the intended issues. Hence video on environment conservation and EVD concept, its impact during phase 1 were shown.

iii. **Identification and collection of potential priority EVD solutions**

At the end of the session, EVD solutions community members’ thinks as a priority for their community were collected.

Issues from community to make their ward eco-friendly:

- Use of waste collection container to make surrounding clean
- Segregation of waste (decomposable and non-decomposable)
- Technique to convert waste to energy
- Plantation of at least 2 tree in each house
- Reduce plastic use
- Waste management from household level
- Turning decomposable waste into fertilizer
- Awareness on environment issues
- Practice of organic farming



Remarks: Ward 2 chairman Mr. Bhagwan Ghimire expressed his happiness that all sections of participants were present in the program. He also informed that behavior change is very important for success of program or any kind of initiatives. Development and environment conservation should go together. He emphasized on public participation and assured that upcoming ward planning will consist EVD component and renewable energy technologies promotion activities.

Remarks from Chairman of Bethanchok Rural Municipality Mr. Prem Bahadur Timilsina: Development and environment should go in hand in hand. All villagers should bear responsibility and perform their duty too. Municipality will impose strict law against cleanliness. He appreciated that this program has been conducted in other wards also. He emphasized on promotion of organic fertilizer. Training on organic fertilizer, pesticides are important and should be organized soon. He requested everyone to use the obtained knowledge into practice. Lastly, he encouraged everyone to make their house eco-friendly and their municipality as model municipality in Nepal.

Conclusion

Altogether 210 people were oriented about the EVD, environment, and climate change issues. About 35% of the participants were female. The program was organized in presence of ward Chairman from each ward and other elected bodies in each ward. With this orientation and awareness program, there is a better understanding among participants' students about climate change, its impact on livelihood of people and agriculture and ways to mitigate or adapt with those impacts and most importantly the EVD concept. We also believe that participants who were considered as an agent of change in their locality are able to demonstrate their level of understanding on climate change issues to their community.
